The Evolution of Regulatory and Sustainability Disclosures: What are the Latest Trends?

Increasingly mainstream investors believe that sustainability factors affect the financial condition or operating performance of companies, and thus affect investors' decisions on whether to buy, sell, or hold a security. While many companies disclose sustainability information in both mandatory filings and voluntary channels, it's often not "investmentgrade." Only 29% of investors express confidence in the quality of the ESG information they receive.
