

Terms and Conditions/Waiver and Release of Liability

NIRI is committed to providing a healthy, safe, productive, and welcoming meeting environment. All participants are required to agree to the terms and conditions and waiver of liability set forth below to attend the in-person **2022 Senior Roundtable Annual Meeting**.

NIRI has taken preventative measures to reduce the spread of communicable disease including but not limited to COVID-19 at the 2022 Senior Roundtable (SRT) Annual Meeting (“2022 SRT Annual Meeting”).

All SRT participants are required to abide by all applicable COVID-19-related requirements, advisories, policies, procedures, and protocols of NIRI (including the NIRI [COVID-19 Duty of Care](#)), the JW Marriott Camelback Inn, as well as the [World Health Organization](#) (WHO), the U.S. [Centers for Disease Control and Prevention](#) (CDC), the State of Arizona, and any other governmental authority for the duration of their stay for the 2022 SRT Annual Meeting.

Any person disclosing or exhibiting symptoms of COVID-19, or knowingly exposed to the disease, will not be admitted to the 2022 SRT Annual Meeting. Any person refusing to comply with required safety protocols will also be asked to leave the 2022 SRT Annual Meeting without refund or the ability to return.
